Nurse Aide Training Classes 2010

Federal and state regulations establish training and testing requirements for all nurse aides who work in Medicare/Medicaid certified long term care facilities. The Ohio Department of Health's NATCEP unit is responsible for ensuring that the nurse aide programs offered in Ohio meet federal and state requirements.

TRAINING AND COMPETENCY EVALUATION PROGRAM (TCE) is an approved program that complies with the regulations of the Ohio department of Health. The course fulfills the seventy five (75) hours of classroom and clinical requirements for students to become eligible for taking the state competency exam for state tested nurse aides. The cost of the state competency exam is \$100 paid directly to the testing company.

ATTENDANCE GUIDELINE – IN ACCORDANCE WITH OHIO DEPARTMENT OF HEALTH REGULATIONS

- Students are required to attend all classroom and clinical sessions.
- Clinical sessions are held at a nursing facility.
- No Absenteeism is permitted within the first sixteen (16) hours of instructions. After the first sixteen (16) hours of instruction excused absences due to illness or family emergency may be permitted. Make up sessions are allowed to be scheduled up to a maximum of three (3) days.
- Beginning with the first session students are required to wear nonwhite uniforms/scrubs for all classroom and clinical sessions.
- TB test or negative chest x-ray are required.

CANCELLATION POLICY

Cancellations for all classes starting on Monday are accepted up to Thursday, 5:00pm of the previous week.

Cost of the State Competency Test is \$100, and will be paid to the State.

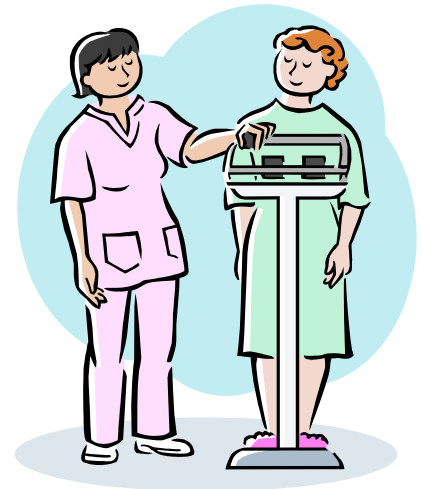

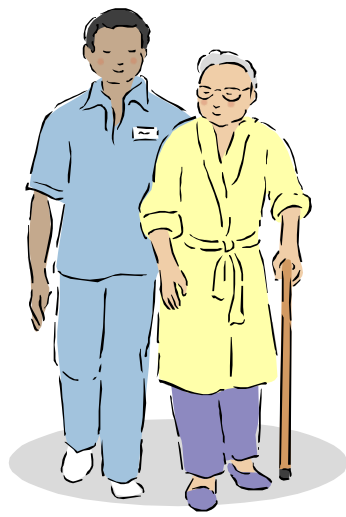
